 d. Resolution No. 56-R-2020 – A Resolution of the Town of Mead, Colorado, Approving a Professional Services Agreement with Loveland Barricade LLC, for Pavement Marking and Striping Application Services

Town Engineer / Public Works Director Erika Rasmussen discussed the proposal.

Motion was made by Mayor Pro Tem Adams, seconded by Trustee Brodhead, to adopt Resolution No. 56-R-2020 – A Resolution of the Town of Mead, Colorado, Approving a

Professional Services Agreement with Loveland Barricade LLC, for Pavement Marking and Striping Application Services for an amount not to exceed \$75,000.00. Motion carried 7-0, on a roll call vote.

e. **Resolution No. 57-R-2020** – A Resolution of the Town of Mead, Colorado, Approving a Services Agreement with Browns Hill Engineering & Controls, LLC, for Certain Hardware and Software-Related Services at the Town's Wastewater Treatment Facility

Town Engineer / Public Works Director Erika Rasmussen discussed the maintenance need which was unbudgeted. Staff will prioritize budgeted work on the pipeline project and delay some of the work until 2021 in order to meet the 2020 budgeted amount for repairs and maintenance.

Motion was made by Trustee Harris, seconded by Trustee Cartwright, to adopt Resolution No. 57-R-2020 – A Resolution of the Town of Mead, Colorado, Approving a Services Agreement with Browns Hill Engineering & Controls, LLC, for Certain Hardware and Software-Related Services at the Town's Wastewater Treatment Facility for an amount not to exceed \$27,825.00. Motion carried 7-0, on a roll call vote.

Planning Director Chris Kennedy presented information regarding ongoing development projects – both residential and commercial.
