1. Call to Order - Roll Call

Town Manager Helen Migchelbrink discussed the Oviatt cabin at Highland Lake which was moved to the historic society property by Wendy Meehan; the Town has been awarded \$90,000 Fishing is Fun grant for Highland Lake Park improvements; elementary school demolition will be within next few weeks; home sales continue to be strong at The Highlands and Sorrento; yard cleanup June 19 was successful.

10. Public Hearing

a. **Ordinance No. 936** – An Ordinance of the Town of Mead, Amending Certain Provisions of Articles I, II, III, VII, and XI of Chapter 16 of the *Mead Municipal Code* Pertaining to Signage, Accessory Dwelling Units, and Accessory Structures

Mayor Whitlow opened the public hearing for amendments to the Mead Municipal Code at 8:33 p.m.

Town Planner Jeremiah Fettig discussed the proposed amendments.

Allocation of Funding be Directed to the Weld County Business Relief Fund to be Administered by Upstate Colorado Economic Development

The Board discussed the collaboration agreement among Weld County and many municipal jurisdictions to set up a grant funding process through Upstate Colorado to distribute CARES Act funding to local businesses.

Motion was made by Trustee Babcock, seconded by Mayor Pro Tem Adams, to adopt Resolution No. 62-R-2020 – A Resolution of the Town of Mead, Colorado, Approving a Collaboration Agreement Related to Distribution of Cares Act Funds with Weld County, Colorado, and Directing that 100% of the Town of Mead's Allocation of Funding be Directed to the Weld County Business Relief Fund to be Administered by Upstate Colorado Economic Development. Motion carried 7-0, on a roll call vote.

 Approving a Special Project Task Order for JVA, Inc. to Complete Phase 1 of the
 North Creek Ditch Floodplain Analysis

Town Engineer / Public Works Director Erika Rasmussen discussed the Floodplain Analysis process.

SUBJECT: Town Manager Report

Administration

- The move of the ditch rider cabin at Highland Lake is complete. It is now being installed at the Highland Lake Church property.
- Mosquito spraying: The spraying only occurs when we reach the threshold of mosquitos in the traps, which has not yet occurred. When it does, the Town will spray on streets within Town limits. Data report dated June 30, 2020, is attached.
- The Town's social media engagement has increased significantly in June.
- The FedEx building foundation and floor have been poured and the construction is moving along on schedule.
- The Mead Towne Center project resumed construction activities on July 6.
- The next Richie Brothers auction is slated for August 5. There are currently 1300 items up for bid.
- Municipal Court has a trial scheduled for July 13. There are 30 cases scheduled for arraignment on July 16.
- YTD totals for single family home permits:
 - o 2019 11 total SF Permits
 - o 2020 YTD 90 SF Permits
- Boards and Commissions
 - o The Planning Commission is not meeting in July.
 - o Events Committee is on hiatus until events can be planned.
 - o Finance Committee is slated to meet in August.
- Human Resources
 - The Town is seeking 3 additional officers, a Code Enforcement Officer and one SRO.
 - o One officer is starting July 20.
 - o Interviews are underway for the Public Information Officer position.

Planning and Building

- Staff has received notification that the State of Colorado is awarding the Town of Mead a grant in the approximate amount of \$90,000 through the Fishing is Fun program to fund improvements to Highland Lake Park. Staff is coordinating with state officials on the details and will present a formal item for the Board's consideration in the coming weeks.
- Staff received seven (7) responses to the recently issued RFP for Building Services and will be working to vet proposals prior to selection of a firm and presentation of a contract to the Board of Trustees for approval.

Public Works and Engineering

- The CR 7/CR 32 intersection will be reconstructed as part of the Sorrento subdivision off-site improvements. Work is expected to begin July 13, and will last approximately 5 weeks. Detours and delays are to be expected.
- Staff is exploring replacement options of the sand and salt shed at Mead Ponds due to catastrophic damage during the last wind storm.
- Concrete removal and replacement began July 6, and is expected to last throughout the month.
- Dust control was completed on the gravel road network.
- Paving is complete at the next phase of The Highlands development. Staff is preparing the punch list for conditional acceptance.
- The streets at Sorrento phases 4 and 5 have been cement treated due to unstable subgrade. Paving is expected in July.

Community Engagement

- July Mead Messenger published on July 1.
- Prepared information about Weld County CARES Act grant, police outlook and pavement management for social media and website.
- Yoga in Park held a successful class, we will be adding second workshop in August.
- Registrations for camps have maintained 12-18 kids per session, looking at having toddler camps in Fall.
- Social media engagement, page likes, post reach, and followers up significantly over the last month. Facebook: Engagement up 94%, Likes up 220%, Reach up 322%, added 66 followers in the last month.



SUMMARY

Ordinance No. 937 (the "Ordinance") approves a disconnection of 3.54 acres from the boundaries of the Town of Mead.

A disconnection removes property from the municipal boundaries of the Town.

Section 16-8-130 of the *Mead Municipal Code* ("MMC") sets forth that all disconnections of property from the Town shall comply with the Colorado Municipal Annexation Act of 1965, as amended ("Act").

The Town of Mead is the owner of the property described in <u>Exhibit A</u> of the Ordinance (the "Subject Property") which generally consists of the western half of the existing right-of-way of Weld County Road 9-1/2 ("WCR 9.5") and portions of that certain property deeded to the Town by special warranty deed dated March 29, 2007 and recorded April 6, 2007 at Reception No. 3467195 in the real property records of Weld County, Colorado.

The Subject Property consists of approximately 3.54 acres and is shown in the Disconnection Map, a copy of which is on file with the Town Clerk and a copy of which is attached to this *Agenda Item Summary* ("AIS").

By letter dated June 5, 2020, a copy of which is attached to this AIS ("June 5 Letter"), the Town provided written notice to the Weld County Board of County Commissioners regarding the proposed disconnection of the Subject Property. The June 5 Letter confirms that the Board of Trustees would consider the disconnection of the Subject Property at its July 13, 2020 regular meeting.

BACKGROUND

Town staff is recommending approval of the disconnection in order to facilitate the subsequent annexation of the Subject Property to the Town of Firestone, as Firestone will be responsible for the ongoing maintenance of WCR 9.5, including but not limited to signalization of the WCR 9.5 and Weld County Road 28 intersection and paving operations.

The Ordinance approves the disconnection of the Subject Property and authorizes the Town Clerk to perform all statutory duties to complete the disconnection.

The Ordinance also: (1) authorizes the Mayor to execute the Disconnection Map (once in final form, and approved by the Town Engineer and Town Attorney); (2) authorizes the Mayor to execute an annexation petition seeking the annexation of the Subject Property to Firestone and to take other steps as necessary to effectuate the annexation of the Subject Property to Firestone.

WHEREAS, Sec. 16-8-130 of the *Mead Municipal Code* sets forth that all disconnections of property from the Town shall comply with the Colorado Municipal Annexation Act of 1965, as amended; and

WHEREAS, the Town of Mead is the owner of that certain property described in **Exhibit A** attached hereto which generally consists of the western half of the existing right-of-way of Weld County Road 9-1/2 ("WCR 9.5") and portions of that certain property deeded to the Town by special warranty deed dated March 29, 2007 and recorded April 6, 2007 at Reception No. 3467195 in the real property records of Weld County, Colorado ("Town Parcel") (together, the "Subject Property"); and

WHEREAS, the Subject Property consists of 3.54 acres, more or less, and the boundaries of the same are shown in that certain disconnection map of record with the Town Clerk ("Disconnection Map"); and

WHEREAS, the Board of Trustees of the Town of Mead ("Board") provided written notice to the Board of County Commissioners of Weld County regarding the proposed disconnection of the Subject Property; and

WHEREAS, the Board has given due consideration to the disconnection of the Subject Property from the boundaries of the Town and finds that the best interests of the Town will not be prejudiced by said disconnection; and

WHEREAS, the Board also finds that no special terms or conditions shall be imposed on the disconnection; and

WHEREAS, the Board desires to approve the disconnection of the Subject Property in order to facilitate the subsequent annexation of the Subject Property to the Town of Firestone ("Firestone"), as Firestone will be responsible for the ongoing maintenance of WCR 9.5, including but not limited to signalization of the WCR 9.5 and Weld County Road 28 intersection and paving operations; and

WHEREAS, in connection with the disconnection of the Subject Property, the Board desires to authorize the Mayor to execute a quitclaim deed conveying the Town Parcel to the

Town of Mead for roadway and associated purposes (the "Quitclaim Deed"), so as to clarify the nature and limited use of the Town Parcel as right-of-way; and

- **WHEREAS**, the Board further desires to authorize the Mayor to take such steps as may be necessary or desirable to effectuate the annexation of the Subject Property to Firestone including, but not limited to, executing an annexation petition related thereto;
- **NOW THEREFORE, BE IT ORDAINED** by the Board of Trustees of the Town of Mead, Weld County, Colorado, that:
- **Section 1.** The Subject Property is hereby disconnected from, as is no longer a part of, the Town of Mead, Colorado. Immediately upon the filings being made in accordance with C.R.S. § 31-12-501(4), the Subject Property shall be in unincorporated Weld County, Colorado.
- **Section 2.** The Town Clerk is hereby authorized and directed to perform all statutory duties to complete the disconnection. Specifically, and following the effective date of this Ordinance as set forth in Section 5 below, the Town Clerk is authorized and directed to file two (2) certified copies of this Ordinance with the Weld County Clerk and Recorder, together with a written request that the County Clerk proceed to file the second certified copy with the Colorado Division of Local Government, as required by C.R.S. § 31-12-501(4). The Town Clerk shall also file a copy of the Disconnection Map with the Weld County Clerk and Recorder. The Mayor shall be authorized to execute the Disconnection Map, once approved by the Town Engineer and Town Attorney.
- **Section 3.** The Mayor shall be authorized to execute the Quitclaim Deed referenced above, in a form approved by the Town Attorney. The Quitclaim Deed shall be recorded in the Weld County property records prior to recordation of this Ordinance and the Disconnection Map.
- **Section 4.** The Mayor shall also be authorized to: (1) execute an annexation petition seeking the annexation of the Subject Property to Firestone, and (2) to take any other steps to effectuate the annexation of the Subject Property to Firestone. The Town Clerk is hereby authorized and directed to attest the Mayor's signature, as necessary on the annexation petition, certificate of ownership set forth on the annexation map, or related documents.
- **Section 5. Effective Date.** This ordinance shall be published and become effective as provided by law.
- **Section 6. Repealer.** All ordinances, resolutions, or other regulations, or any parts thereof, in conflict with this Ordinance are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such, nor revive any ordinance, resolution, or regulation thereby.
- **Section 7. Certification.** The Town Clerk shall certify to the passage of this Ordinance and make not less than one copy thereof available for inspection by the public during regular business hours.

Section 8. Severability. If any part, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of the Ordinance. The Board hereby declares that it would have passed the Ordinance including each part, section, subsection, sentence, clause or phrase thereof, irrespective of the fact that one or more part, section, subsection, sentence, clause or phrase is declared invalid.

SUMMARY

The Town does not currently have code language related to the management of rodent populations in areas that are not appropriate habitats, including parks and residential subdivisions. This ordinance provides a mechanism to manage rodent infestations by defining them as a public nuisance and providing enforcement through the abatement process already defined in the code. This process includes notifying the property owner, and if the nuisance is not corrected, the Town may issue a citation or complete the abatement and assess the property owner for the costs incurred.

The term *rodents* shall mean any moles, voles, mice, rats, squirrels, skunks, rabbits, prairie dogs, gophers or ground hogs. The term *infested* refers to the presence, within or around real property, of rodents of such kind or in such numbers to cause a hazard to health. A hazard to health includes the presence of rodents on real property that is not an appropriate rodent habitat by virtue of its land uses.

FINANCIAL CONSIDERATIONS

There are no financial impacts to the Town.

TOWN OF MEAD, COLORADO ORDINANCE NO. 938

AN ORDINANCE OF THE TOWN OF MEAD, COLORADO, AMENDING ARTICLE II OF CHAPTER 7 OF THE MEAD MUNICIPAL CODE BY ADDING A NEW SECTION 7-2-190 CONCERNING CONTROL OF RODENT INFESTATIONS

WHEREAS, the Board of Trustees of the Town of Mead ("Board of Trustees") has the authority pursuant to C.R.S. § 31-15-401 and its general police powers to pass and enforce regulations that may be necessary or expedient for the promotion of the health, safety and welfare of the citizens of the Town of Mead ("Town"); and

WHEREAS, if left unregulated, populations of rodents may become a public nuisance and health hazard; and

WHEREAS, the Town requires a mechanism to manage rodent infestations and control rodent populations in areas of the Town that are not appropriate rodent habitats by virtue of their current or planned land uses; and

WHEREAS, the Board of Trustees finds that it is in the best interest of the health, safety and welfare of the Town to adopt the regulations set forth herein.

NOW THEREFORE, BE IT ORDAINED by the Board of Trustees of the Town of Mead, Weld County, Colorado, that:

Section 1. Addition of Section 7-2-190. A new Section 7-2-190, titled "Control of rodent infestations," is hereby added to Article II of Chapter 7 of the Mead Municipal Code to read in full as follows:

Sec. 7-2-190. – Control of rodent infestations.

- (a) It is deemed a public nuisance to allow any real property within the Town to become or remain infested with rodents.
- (b) For the purposes of this Section, the following terms shall have the following meanings:
 - (1) The term *rodents* shall mean any moles, voles, mice, rats, squirrels, skunks, rabbits, prairie dogs, gophers or ground hogs.
 - (2) The term *infested* refers to the presence, within or around real property, of rodents of such kind or in such numbers to cause a hazard to health.
 - (3) The term *hazard to health* shall include but shall not be limited to the presence of rodents on real property that is not an appropriate rodent habitat by virtue of

its current or planned future land uses. A health hazard also includes but is not limited to the presence of rodents that is determined by an administrative officer of the Town to pose a risk to the health of Town inhabitants pursuant to Section 7-1-50 of this Code.

- (c) Nothing contained in this Section shall be construed or intended to include within the definition of a public nuisance any animal designated by a state or federal agency as an endangered animal under state or federal law.
- (d) Abatements of the public nuisance defined in this Section shall be completed in accordance with the provisions of this Chapter 7 and applicable state and federal law. The requirements of this Section are in addition to, and do not supersede, any state or federal limitations on the destruction or relocation of rodents, including prairie dogs.

Section 2. Effective Date. This ordinance shall be published and become effective as provided by law.

Section 3. Repealer. All ordinances, resolutions, or other regulations, or any parts thereof, in conflict with this Ordinance are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such, nor revive any ordinance, resolution, or regulation thereby.

Section 4. Certification. The Town Clerk shall certify to the passage of this Ordinance and make not less than one copy thereof available for inspection by the public during regular business hours.

Section 5. Severability. If any part, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of the Ordinance. The Board hereby declares that it would have passed the Ordinance including each part, section, subsection, sentence, clause or phrase thereof, irrespective of the fact that one or more part, section, subsection, sentence, clause or phrase is declared invalid.
