AN ORDINANCE RELATIVE TO WATER RATES, WATER CHARGES, METER REQUIREMENTS, AND THE PAYMENT OF CHARGES AND PENALTIES AMENDING ORDINANCE NO. 23:a SECTION 2.c.; SECTION 3.a.,c.,d.; SECTION 4.a.,b.; SECTION 5; SECTION 6.c.; AND REPEALING SECTION 3.b.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEAD, WELD COUNTY, COLORADO:

Section 1.

Ordinance No. 23 in which Section 3.b. of the Code of the Town of Mead was inacted is hereby repealed. Section 2.

Ordinance No. 23 in which Section 2.c. of the Code of the Town of Mead is hereby amended to read as follows:

The tapping of mains and the installation of all pipes, fittings, meters, and appurtenances necessary for conveying water from the main to the stopcock shall be done by the Water Department of the Town of Mead. The cost of each three-quarter inch tap, or its equivalent, shall be ONE HUNDRED FIFTY AND NO CENTS (\$150.00) DOLLARS for residential taps and THREE HUNDRED AND NO CENTS (\$300.00) DOLLARS for all other taps within town limits, and shall be FIVE HUNDRED AND NO CENTS (\$500.00) DOLLARS per tap outside town limits, plus cost of all pipes, fittings, meters, stopcocks and appurtenances for conveying water from the main to the stopcock, all of which pipes, fittings, meters, stopcocks, and appurtenances shall remain the property of the Town of Mead.

Section 3.

Ordinance No. 23 in which Section 3.a. of the Code of the Town of Mead was inacted is hereby amended to read as follows:

There shall be assessed and charged for the use of water measured through a meter, per month, from any of the water mains of the

Ordinance No. 23 in which Section 3.c. of the Code of the Towm of Mead was inacted is hereby amended to read as follows:

No charge for water shall be less than SEVEN AND NINETY CENTS of (\$7.90) DOLLARS per month for the use within the corporate limits of the Town of Mead.

Section 5.

Ordinance No. 23 in which Section 3.d. of the Code of the Town of Mead was inacted is hereby amended to read as follows:
No charge for water shall be less than TEN AND FORTY CENTS (\$10.40) DOLLARS per month for use outside the corporate limits of the Town of Mead.

Section 6.

Ordinance No. 23 in which Section 4.a. of the Code of the Town of Mead was inacted is hereby amended to read as follows:

All rates and rentals for the use of water as herein provided, shall be due and payable monthly on the TWENTIETH (20th) day of the next and succeeding calendar month.

Section 7.

Ordinance No. 23 in which Section No. 5 of the Code of the Town of Mead was inacted is hereby amended to read as follows:

Whereas, the Board of Trustees of the Town of Mead has determined that it is essential to the future development of the Town of Mead to conserve water, that meters be installed for all water users, and that said meter shall be installed at the expense of the owner of the property on which the meter is installed.

Section 8.

Ordinance No. 23 in which Section No. 5 of the Code of the Town of Mead was inacted is hereby amended to read as follows: Installation of meters, penalties.

All water users shall install meters within THIRTY (30) days after notice shall be given them by the Water Superintendant so to do. Willful failure to so install meters as required, shall subject such water user to a fine of not more than THREE HUNDRED AND NO CENTS (\$300.00) DOLLARS.
