## ordinance no. 36

- AN ORDINANCE RELATIVE TO THE INSTALLATION OF A WATER TAP FOR THE MEAD JUNIOR HIGH SCHOOL AND THE WATER RATES FOR SAID TAP.
- BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEAD, WELD COUNTY, COLORADO:
- Section 1. The Mead Junior High School be allowed to tap the water supply line of the Town of Mead with a Three (3) inch supply line to serve said school for a tap fee of SEVEN HUNDRED FIFTY AND NO/100 (\$750.00) DOLLARS.
- Section 2. The above described tap shall be equipped with an adequate water meter and all such water used by the aforementioned school must be metered.
- Section 3. Said school shall be charged for the use of water from the Town of Mead system according to the following formula, to-wit:
  - (A.) One (1) monthly charge equal to that being paid by a water user residing inside the Town limits of the Town of Mead shall be levied for each Fifteen (15) students enrolled at the fall opening of said school each year.
  - (B.) Once determined, the number of monthly charges to be levied against the school shall not be subject to alteration during the subsequent year because of fluctuations in school enrollment.
  - (C.) Charges for water shall be made in the same manner and at the same rate as for a water user inside the Town limits of the Town of Mead.
- Section 4. Said school shall, in addition to the above described tap fee, be responsible for the payment of all expenses incurred by the Town of Mead in installing the hereinbefore described water tap and meter.
- Section 5. All Ordinances, Resolutions, and Motions of the Board of Trustees of the Town of Mead or parts thereof, in conflict with the provisions of this Ordinance, are to the extent of such conflict hereby superseded and repealed.
- Section 6. Use of water from the Town of Mead by said school shall be in accordance with all Ordinances, Resolutions, Motions and Proclamations of the Board of Trustees of the Town of Mead or the Water Superintendent acting on instructions from said Board not inconsistent herewith.
- Section 7. In the opinion of the Board of Trustees of the Town of Mead, Weld County, Colorado, this Ordinance is necessary for the immediate protection and preservation of the public health,

safety, convenience and general welfare, and it is enacted for the purpose and shall be in full force and effect FIVE (5) days after passage and final publication.
