WHEREAS, the assessed valuation of taxable property for the year 1977 in the Town of Mead, as returned by the County Assessor of Weld County, Colorado, is the sum of THREE HUNDRED THIRTEEN THOUSAND SIX HUNDRED TEN AND NO/100 (\$313,610.00) DOLLARS.
