ORDINANCE NO. 83

AN ORDINANCE AUTHORIZING THE ISSUANCE OF SPECIAL ASSESSMENT BONDS IN THE PRINCIPAL AMOUNT OF \$152,000 OF THE TOWN OF MEAD, COLORADO, FOR SPECIAL IMPROVEMENT DISTRICT NO. 2; PRESCRIBING THE FORM OF THE BONDS, AND PROVIDING FOR THE PAYMENT OF THE BONDS AND THE INTEREST THEREON.

WHEREAS, the Board of Trustees has, by Ordinance No. 81, passed and adopted on December 3, 1979, created Special Improvement District No. 2, for the purpose of constructing and installing curb and gutter improvements; and

WHEREAS, Notice to Contractors to submit bids for the construction of the improvements in the District has been duly published and the contract for such construction has been awarded to Colorado Construction and Concrete, Inc.; and

WHEREAS, Notice of Sale of \$152,000 of Special Assessment Bonds for the District has been duly published and the contract for the sale of the bonds has been awarded to Hanifen, Imhoff & Samford, Inc.; and

WHEREAS, the Board of Trustees has determined that the cost of the construction of improvements, together with necessary incidental costs, shall not exceed the amount of \$152,000, and that bonds of the Town for said District should be issued in such amount; and

WHEREAS, it is now necessary to provide for the issuance of said bonds and the form and payment thereof;

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEAD, COLORADO:

Bond Details. By virtue of and pursuant to the Laws of the State of Colorado, Special Assessment Bonds of the Town of Mead, for Special Improvement District No. 2, shall be issued for the purpose of paying for local improvements to be constructed in said District. The bonds shall be in the principal amount of \$152,000, shall be dated July 1, 1980, and consist of 152 bonds in the denomination of \$1,000 each, numbered 1 to 152, The bonds shall be payable to bearer and shall be due and payable on September, 1, 1990, subject to call and prior payment in direct numerical order on any interest payment date, upon payment of par and accrued interest. Notice of such prior redemption shall be published once a week for three consecutive weeks (4 times) in a newspaper of general circulation in the Town. The notice shall specify by number the bonds so called, and all bonds shall be paid in their numerical order. The holder of any such bonds may at any time furnish his or her post office address to the Town Treasurer, and in such case, a copy of the notice shall be mailed by the Town Treasurer to the bondholder, at such address, on or before the first day of such publication.

The bonds shall bear interest as evidenced by "A" coupons attached to said bonds, payable on March 1, 1981, and semiannually thereafter on March 1 and September 1, each year, as follows:

In addition to the "A" interest rates set forth above, bonds numbered 1 to 97, inclusive, shall bear additional interest as evidenced by supplemental coupons designated "B", payable on March 1, 1981, September 1, 1981, March 1, 1982 and September 1, 1982, at the rate and for the period from September 1, 1980 to the date indicated below, or to the payment date of the bond, whichever is the earlier date, as follows:

The net effective interest rate of this issue of bonds is 9.52992% per annum.

Section 2. Execution of Bonds and Interest Coupons. The bonds shall be signed with the facsimile signature of the Mayor of the Town, sealed with a facsimile of the seal, attested and countersigned by the manual signature of the Town Clerk-Treasurer, and the interest coupons attached thereto shall be

signed with the facsimile signature of the Town Clerk-Treasurer. When issued as aforesaid as part of said bonds, the interest coupons shall be the binding obligations of the Town according to their import.

The bonds and interest coupons, bearing the signatures of the officers in office at the time of the signing thereof, shall be the valid and binding obligations of the Town, notwithstanding that before the delivery thereof and payment therefor, any or all of the persons whose signatures appear thereon shall have ceased to fill their respective offices.

Section 3. Form of Bonds and Interest Coupons. The bonds and interest coupons to be attached thereto shall be in substantially the following form:

This Bond is subject to call and redemption in direct numerical order of the issue of which it is one, on any interest payment date, upon payment of par and accrued interest to the date of redemption. Notice of such prior redemption shall be published once a week for three consecutive weeks in a newspaper of general circulation in the Town of Mead, prior to the date of redemption. After the redemption date so designated, interest on the bonds so called shall cease.

This Bond is one of a series issued for the purpose of paying the costs of constructing and installing curb and gutter improvements, in Special Improvement District No. 2, in the Town of Mead, Colorado, by virtue of and in full conformity with the Constitution and Laws of the State of Colorado, and an Ordinance of the Town duly adopted, approved, published and made a law of the Town prior to the issuance hereof.

Payment of this Bond and the interest thereon shall be made only from, and as security for such payment there is pledged, a special fund designated as the "Special Improvement District No. 2 Bond and Interest Fund" which Fund shall contain initially any monies in the construction account remaining after the cost of improvements has been paid in full and thereafter to contain the monies collected on account of the assessments to be levied against the property included within the District and specially benefited by the construction and installation of improvements In addition, Section 31-25-534, Colorado Revised Statutes 1973, as amended, and the Ordinance authorizing this Bond, provides that whenever three-fourths of the bonds issued for the construction of improvements under Title 31, Article 25, Part 5, Colorado Revised Statutes 1973, as amended, have been paid and cancelled and for any reason the remaining assessments are not paid in time to pay the remaining bonds for the District and the interest due thereon, the Town of Mead shall pay the bonds when due and the interest due thereon and reimburse itself by collecting the unpaid assessments due the District.

It is hereby certified and recited that the total issue of bonds of the Town for the District, including this Bond, does not exceed the amount authorized by law; that every requirement of law relating to the creation of Special Improvement District No. 2, the construction of said local improvements and the issuance of this Bond has been fully complied with by the proper officers of the Town, and that all conditions required to exist and things required to be done precedent to and in the issuance of this Bond to render the same lawful and valid, have happened, been properly done and performed, and did exist in regular and due time, form and manner, as required by law.

This obligation is not to be considered or taken to be within or any part of the limitation imposed by law as to the indebtedness of the Town, and shall not be a general obligation of the Town.

For the payment of this Bond and the interest thereon, the Town pledges all of its lawful corporate powers.

Section 4. Application of Bond Proceeds. The proceeds of the bonds shall be applied only to pay the costs and expenses of constructing the improvements in the District and all other costs and expenses incident thereto. Neither the purchaser of the bonds nor the holder of any of them shall be in any way responsible for the application of the proceeds of said bonds by the Town or any of its officers. In the event that all of the proceeds of said bonds are not required to pay such costs and expenses, any remaining amount shall be used for the purpose of calling in and paying the principal of and interest on said bonds.

All or any portion of the bond proceeds may be temporarily invested, or reinvested, pending such use, in securities or obligations which are lawful investments for such municipalities in the State of Colorado. It is hereby covenanted and agreed by the Town that the temporary investment or reinvestment of the bond proceeds, or any portion thereof, shall be of such nature and extent, and for such period, that the bonds of the Town shall not become "arbitrage bonds" within the meaning of Section 103(c) of the Internal Revenue Code of 1954, as amended, and pertinent regulations, and such proceeds, if so invested or reinvested, shall be subject to the limitations and restrictions of said Section 103(c), and pertinent regulations, as the same now exists or may later be amended.

Section 5. Special Improvement District No. 2 Bond and Interest Fund. The bonds and the interest thereon shall be payable solely from the local improvement fund, designated as the "Special Improvement District No. 2 Bond and Interest Fund", which shall contain initially any monies in the construction account remaining after the cost of improvements has been paid in full and thereafter to contain the monies collected on account of the assessments to be levied against the property within the District and specially benefited by the construction of improvements therein. Whenever the Town Treasurer has funds in the treasury to the credit of Special Improvement District No. 2, exceeding six months' interest on the unpaid principal of the bonds issued and outstanding, bonds shall be called for payment, by advertisement in a newspaper of general circulation in the Town, in accordance with Section 1 of this Ordinance.

After the expiration of the period for cash payments of assessments in full, the Town shall, to the extent possible, pay each year not less than 10% of the total amount of bonds outstanding after the payment of the bonds with the proceeds of such cash payments of assessments in full.

Section 6. Additional Security For the Payment of Principal and Interest. Pursuant to the provisions of Section

31-25-534, Colorado Revised Statutes 1973, as amended, whenever three-fourths of the bonds for the improvements constructed under the provisions of said Part 5 have been paid and cancelled, and for any reason the remaining assessments are not paid in time to pay the remaining bonds for the District and the interest due thereon, the Town of Mead shall pay the bonds when due and the interest due thereon and reimburse itself by collecting the unpaid assessments due the District.

Section 7. Assessment of Costs. Upon completion of the

Section 7. Assessment of Costs. Upon completion of the local improvements, or upon completion from time to time of any part thereof, or whenever the total cost can be definitely ascertained, the Board of Trustees shall cause to be prepared a statement showing the whole cost of the improvements, the portion thereof to be paid by the Town, if any, and apportion the cost upon each lot or tract of land to be assessed for the construction of improvements. The Board of Trustees shall further cause assessments to be levied against the property included within the special improvement district and specially benefited by the construction and installation of such improvements, in accordance with law.

Section 8. Repealer. All ordinances, or parts thereof in conflict herewith are hereby repealed.

Section 9. Recording and Authentication. This Ordinance, after its passage, shall be recorded in a book kept for that purpose, shall be authenticated by the signatures of the Mayor and Town Clerk and be published in the official newspaper of the Town, in accordance with law.

Section 10. <u>Declaration of Emergency</u>. By reason of the fact that it is necessary to proceed with the construction and installation of improvements as soon as possible, and that it is necessary to issue bonds in order to pay the costs of construction and installation which will hereafter become due, it is hereby declared that this ordinance is necessary for the preservation of the public peace, health or safety, shall be passed and approved as an emergency ordinance, and become effective upon publication.
