## ordinance no. 9/

AN ORDINANCE FOR THE ANNEXATION OF CERTAIN TERRITORY TO THE TOWN OF MEAD, WELD COUNTY, COLORADO, SPECIFICALLY ANNEXING THE TERRITORY TO THE TOWN OF MEAD AS THE AMES FIRST ADDITION.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEAD, WELD COUNTY, COLORADO:

WHEREAS, the following described unincorporated territory in the County of Weld, State of Colorado, is eligible for annexation to the Town of Mead, under the applicable laws of the State of Colorado, to-wit:

## PARCEL I

A parcel of land situated in the SW¼ of Section 10, Township 3 North Range 68 West of the 6th P.M.; Weld County, Colorado and more particularly described as follows:

Beginning at the South & corner of Section 10 and running west along the south line of same South 1567 feet more or less to the true point beginning thence from said true point of beginning running (1) West 150 feet thence (2) North 340 feet thence (3) West 129 feet thence (4) North 380 feet thence (5) North 89° 53' East 219.66 feet thence (6) South 17° 26' West 183.31 feet thence (7) North 87° 26' East 114.52 feet thence (8) South 550.2 feet to the true point of beginning. Containing 3.26 acres of land more or less.

## PARCEL II

A parcel of land situated in the  $SW_2$  of Section 10, Township 3 North Range 68 West of the 6th P.M.; Weld County, Colorado and more particularly described as follows:

Beginning at the South ½ corner of Section 10 and running west along the south line of some 1846 feet thence North 740 feet to the true point of beginning thence from said point of true beginning running (1) North 60 feet thence (2) West 426 feet thence (3) North 9° 20' East 827.18 feet thence (4) East 673 feet thence (5) South 450 feet thence (6) South 87° 26' West 21.92 feet thence (7) South 17° 26' West 445.24 feet thence (8) South 89° 53' West 225.86 feet to the true point of beginning. Containing 13.53 acres of land more or less.

WHEREAS, a written Petition in proper form and signed by the owners of ONE HUNDRED (100%) PERCENT of the area of said territory to be annexed has been presented to and filed with the Board of Trustees of the Town of Mead which Petition was accompanied by SIX (6) copies of a map or plat of said territory, and

WHEREAS, all of the necessary prerequisites required by the laws of the State of Colorado have been pleaded by the Petitioners and the Petitioners above-mentioned are now entitled to the approval of the Board of Trustees of the Town of Mead, for such annexation.

NOW, THEREFORE, the Board of Trustees of the Town of Mead, Colorado, ordains as follows:

Section 1. That the above described property be annexed to and be included within the corporate limits of the Town of

Mead.

Section 2. That said annexed territ the Ames First Addition to the Town of Mead. That said annexed territory be known as

That the Mayor and Town Clerk of the Town of Mead are authorized and directed to complete all the necessary procedures required for annexation of said property to the Town of Mead, in accordance with the provisions of the laws of the State of Colorado.
