AN ORDINANCE FOR THE ANNEXATION OF CERTAIN TERRITORY TO THE TOWN OF MEAD, WELD COUNTY, COLORADO, SPECIFICALLY ANNEXING THE TERRITORY TO THE TOWN OF MEAD AS THE C.J.K. ADDITION.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEAD, WELD COUNTY, COLORADO:

WHEREAS, the following described unincorporated territory in the County of Weld, State of Colorado, is eligible for annexation to the Town of Mead, under the applicable laws of the State of Colorado, to-wit:

That part of the South one-half of Section 10, Township 3 North, Range 68 West of the 6th p.m., Weld County, Colorado, being more particularly described as follows:
