## ORDINANCE NO. 146

AN ORDINANCE APPROPRIATING ADDITIONAL SUMS OF MONEY TO DEFRAY EXPENSES IN EXCESS OF AMOUNTS BUDGETED FOR THE TOWN OF MEAD, COLORADO, DURING THE FISCAL YEAR OF 1985.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEAD, WELD COUNTY, COLORADO:

WHEREAS, the Town Board of Trustees authorized the expenditure of certain funds from the Conservation Trust Fund and the Revenue Sharing Fund for capital improvements to the Town Park; and

WHEREAS, certain expenditures for the upgrading of the water system were budgeted to take place during 1984, but were not completed and paid for until 1985; and

WHEREAS, this contingency could not have been reasonably foreseen at the time of the adoption of the 1985 budget; and

WHEREAS, adequate funds are available in the same fund in the form of unappropriated or unrestricted surpluses to cover these additional expenditures.

NOW, THEREFORE, be it ordained by the Board of Trustees of the Town of Mead, Colorado:

- Section 1. That the 1985 appropriation for the Conservation Trust Fund is hereby increased from \$2,000.00 to \$4,239.00.
- Section 2. That the sum of \$2,239.00 is hereby transferred from unappropriated and unrestricted surpluses in the Conservation Trust Fund to the Conservation Trust Fund.
- Section 3. That the 1985 appropriation for the Revenue Sharing Trust Fund is hereby increased from \$2,262.00 to \$4,685.00.
- Section 4. That the sum of \$2,528.00 is hereby transferred from unappropriated and unrestricted surpluses in the Revenue Sharing Trust Fund to the Revenue Sharing Trust Fund.
- Section 5. That the 1985 appropriation for the Waterworks Operating Fund is hereby increased from \$120,480.00 to \$201,313.00
- Section 6. That the sum of \$80,833.00 is hereby transferred from unappropriated and unrestricted surpluses in the Waterworks Operating Fund to the Waterworks Operating Fund.
- Section 7. Validity. The provisions of this Ordinance are hereby declared to be severable and if any section, provisions or part thereof shall be held unconstitutional or invalid, the remainder of this Ordinance shall continue in full force and effect, it being the intent of the Board of Trustees that this Ordinance would have been adopted even if such

unconstitutional or invalid matter had not been included herein. It is further declared that if any section, provision or part of this Ordinance or the application thereof to any person or circumstances, if held invalid, the remainder of this Ordinance and the application thereof to other persons or circumstances shall not be affected thereby.

Section 8. Necessity. In the opinion of the Board of Trustees of the Town of Mead, this Ordinance is necessary for the immediate preservation and protection of the health, safety, welfare and property of the inhabitants and owners of property in the Town of Mead.
