AN ORDINANCE AMENDING SECTION 23-6-1 OF THE CODE OF THE TOWN OF MEAD, COLORADO, TO ESTABLISH WATER RATES FOR THE USE OF WATER THROUGH THE TOWN OF MEAD WATER SYSTEM.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Town of Mead, Colorado, that:

Section 1. Section 23-6-1 of the Code of the Town of Mead is hereby repealed in its entirety and a new Section 23-6-1 is hereby adopted as follows:

"23-6-1. Water Rates. There shall be assessed and charged for the use of water measured through a meter, per month, from the Town of Mead Water System the following rates:

1.1 For water users within the corporate limits of the Town of Mead there shall be charged;

1.2 For water users outside the corporate limits of the Town of Mead there shall be charged a monthly water charge equal to 1.5 times the in-town water charge for each meter size provided in subsection 1.1 above. The "Water Usage Charge" shall be equal to the in-town "Water Usage Charge.""

Section 2. Validity. The provisions of this ordinance are hereby declared to be severable and if any section, provision or part thereof shall be held unconstitutional or invalid, the remainder of this ordinance shall continue in full force and effect, it being the intent of the Board of Trustees that this ordinance would have been adopted even if such unconstitutional or invalid matter had not been included herein. It is further declared that if any section, provision or part of this ordinance or the application thereof to any person or circumstances, if held invalid, the remainder of this ordinance and the application thereof to other persons or circumstances shall not be affected thereby.

Section 3. Necessity. In the opinion of the Board of Trustees of the Town of Mead, this ordinance is necessary for the preservation and protection of the health, safety, welfare and property of the inhabitants and owners of property in the Town of Mead.

Section 4. Certification. The Town Clerk shall certify to the passage of this ordinance and make not less than three copies of the adopted Code available for inspection by the public during regular business hours.
