### TOWN OF MEAD, COLORADO ORDINANCE NO 198

# AN ORDINANCE AMENDING ORDINANCE 95 AND THE MODEL TRAFFIC CODE, 1977 EDITION, AS PREVIOUSLY ADOPTED, BY ADDING THE TRAFFIC CONTROL SCHEDULE HERETO.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEAD, WELD COUNTY, COLORADO:

SECTION 1: Ordinance No. 95, Town of Mead, by which Ordinance there was adopted by reference the Model Traffic Code for Colorado Municipalities as approved and published in 1977 by the Department of Highways of the State of Colorado, is hereby amended by adopting as an amended Traffic Control Schedule and the same is attached hereto and made a part hereof.

SECTION 2: The Town Clerk shall certify to the passage of this ordinance, and the attachment, cause notice of the contents and passage to be published, and make not less than three copies of the ordinance, attached Traffic Control Schedule, and Reference Code, available for public inspection; during regular business hours.

SECTION 3: In the opinion of the Board of Trustees of the Town of Mead, Weld County, Colorado, this Ordinance is necessary for the immediate protection and general welfare, and it is enacted for that purpose and shall be in full force and effect as provided by law.

## TRAFFIC CONTROL SCHEDULES FOR DESIGNATED STREETS

#### SCHEDULE I

<u>Sec. 26-1</u>. <u>Through Streets</u>. In accordance with the provisions of Section 2-1, and when official signs are erected giving notice thereof, drivers of vehicles shall stop or yield as required by said signs at every intersection, before entering any of the following streets or parts of streets:

In accordance with the provisions of sections 9-2, 17-21 and 18-1, and when official signs are erected giving notice thereof, no pedestrian, bicyclist or other non-motorized traffic and no person operating a motorized bicycle or a motor-driven cycle shall use any of the following streets or highways or parts thereof:

1. Highway I-25 between WCR 32 and WCR 36 both N. and S. bound.

#### SCHEDULE VII

Sec. 26-7. Stopping, Standing or Parking During Certain Hours on Certain Streets Prohibited. In accordance with the provisions of section 12-2, and when official signs are erected giving notice thereof, no person shall stop, stand or park a vehicle between the hours specified herein of any day, upon any of the streets or parts of streets as follows:
