TOWN OF MEAD, COLORADO ORDINANCE 199

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF THE MEAD MUNICIPAL CODE REGARDING THE CLASSIFICATION OF OFFENSES AS PETTY OFFENSES OR MISDEMEANORS

WHEREAS, THE BOARD OF TRUSTEES OF THE TOWN OF MEAD HAS DETERMINED THAT IT IS NECESSARY TO RECLASSIFY SOME CODE PROVISIONS AS PETTY OFFENSES OR MISDEMEANORS.

<u>Section 1</u>. Chapter 7, Section 3, Subsection 20 of the Mead Town Code, 1986, entitled "Habitually Noisy Animals Prohibited", is hereby amended to read:

Violation of this provision is a petty offense.

Section 2. Chapter 7, Section 3, Subsections 1 through 19, and Subsection 21, of the Mead Town Code, 1986, are hereby amended to read:

Violation of this provision is a misdemeanor.

<u>Section 3</u>. Chapter 7, Section 4, Subsections 1 through 12, of the Mead Town Code, 1986, are hereby amended to read:

Violation of this provision is a misdemeanor.

<u>Section 4.</u> Chapter 7, Section 4, Subsection 19, of the Mead Town Code, 1986, entitled "Nuisance", is hereby amended to read:

Violation of this provision is a petty offense.

<u>Section 5</u>. Chapter 13, Section 1, Subsection 2, of the Mead Town Code, 1986, entitled "Accumulation of Refuse; Prohibited and Declared Nuisance", is hereby amended to read:

Violation of this provision is a misdemeanor.

<u>Section 24</u>. Chapter 16, Section 8, Subsection 5, of the Mead Town Code, 1986, entitled "Aiding and Abetting", is hereby amended to read:

Violation of this provision is a misdemeanor.
