

**TOWN OF MEAD, COLORADO
RESOLUTION NO. 23-R-2003**

A RESOLUTION OF THE TOWN OF MEAD COLORADO, ORDERING THE PUBLICATION AND SETTING A HEARING DATE FOR CONSIDERATION OF THE ADOPTION BY REFERENCE THE THE *INTERNATIONAL BUILDING CODE, 2003 EDITION*, CHAPTERS 1 THROUGH 35 AND APPENDIX C, E, F, G, I AND J; THE *INTERNATIONAL RESIDENTIAL CODE, 2003 EDITION*, CHAPTERS 1 THROUGH 43 AND APPENDIX CHAPTERS E, F, G AND H; THE *INTERNATIONAL MECHANICAL CODE, 2003 EDITION*, CHAPTERS 1 THROUGH 15; THE *NATIONAL ELECTRICAL CODE, 1999 EDITION*, NFPA NO. 70-1999; THE *INTERNATIONAL FUEL GAS CODE, 2003 EDITION*, CHAPTERS 1 THROUGH 8; THE *INTERNATIONAL PLUMBING CODE, 2003 EDITION*, CHAPTERS 1 THROUGH 13; THE *UNIFORM CODE FOR THE ABATEMENT OF DANGEROUS BUILDINGS, 1997 EDITION*; *SEWAGE SYSTEMS*, THE *WELD COUNTY CODE* CHAPTER 30 AND APPENDIX A THROUGH I.

WHEREAS, the Town of Mead is authorized by Part 2 of Article 16 of Title 31, C.R.S. to adopt ordinance codes by reference; and

WHEREAS, The Town is required to introduce the codes to be adopted by reference at a meeting of the Board of Trustees and after such introduction schedule a public hearing thereon. Notice of the hearing shall be published twice in a newspaper of general circulation in the adapting municipality, once at least 15 days preceding the hearing and once at least eight days preceding it.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEAD, WELD COUNTY, COLORADO; THAT;

Section 1. There is hereby introduced an ordinance, to be numbered upon its final adoption, providing for the adoption by reference of the *International Building Code, 2003 Edition*, Chapters 1 through 35 and Appendix C, E, F, G, I and J; the *International Residential Code, 2003 Edition*, Chapters 1 through 43 and Appendix Chapters E, F, G and H; the *International Mechanical Code, 2003 Edition*, Chapters 1 through 15; the *National Electrical Code, 1999 Edition*, NFPA No. 70-1999; the *International Fuel Gas Code, 2003 Edition*, Chapters 1 through 8; the *International Plumbing Code, 2003 Edition*, Chapters 1 through 13; the *Uniform Code for the Abatement of Dangerous Buildings, 1997 Edition*; *Sewage Systems*, the *Weld County Code* Chapter 30 and Appendix A through I, to be known collectively as the **Mead Building Code**.

Section 2. A public hearing for the Mead Building Code shall be conducted by the Board of Trustees at the regularly scheduled meeting to be held November 24, 2003, at 7:00 P.M., in the Mead Town Hall, 441 3rd Street, Mead, Colorado.

Section 3. The Town Clerk is hereby directed to cause to be published and posted a notice of said public hearing in the manner prescribed by C.R.S. § 31-16-203.

Section 4. **Effective Date.** This resolution shall be become effective immediately upon adoption.


Section 5. **Repealer.** All resolutions, or parts thereof, in conflict with this resolution are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such

resolution nor revive any resolution thereby.


Section 6. Certification. The Town Clerk shall certify to the passage of this resolution and make not less than one copy of the adopted resolution available for inspection by the public during regular business hours.
