## TOWN OF MEAD, COLORADO RESOLUTION NO. 3-R-2002

A RESOLUTION OF THE TOWN OF MEAD COLORADO, DECLARING CERTAIN PERSONAL PROPERTY TO BE SURPLUS AND ALLOWING IT TO BE SOLD IN COMPLIANCE WITH LAW.

WHEREAS, C.R.S. § 31-15-101 (1) (d) grants authority to the Town to acquire, hold, lease, and dispose of property, both real and personal; and

WHEREAS, it is the desire of the Board of Trustees to declare surplus and dispose of certain personal property of the Town which is no longer in regular use, or of significant benefit to the Town;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEAD, WELD COUNTY, COLORADO; THAT;

- Section 1. The following personal property of the Town of Mead is hereby declared surplus and eligible for disposal by the Town Administrator to the highest bidder at auction, or by sealed bid following published notice offering said equipment for sale, or as a trade-in on replacement vehicles or equipment. All equipment is to be sold "as is" with no warranty. It is the expressed intent of the Board of Trustees to grant the authority to the Town Administrator to select the most appropriate method of disposal for each item, complete the sale in the best interest of the Town and to execute such documents as may be necessary to consummate the sale. The items to be sold are as follows:

  - 8. 1996 Sanitary Sewer Lift Station components:
    - 1) Kohler (Ford/Onan) Generator, Model 35R272, Serial # 373819.
    - Two (2) submersible pumps, 11 HP with 4-inch discharge, rated at 50 GPM @ 67-foot TDH.
    - 3) Electrical boxes.
    - 4) Telephone line hook-ups.
- Section 2. Effective Date. This resolution shall be become effective immediately upon adoption.
- **Section 3.** Repealer. All resolutions, or parts thereof, in conflict with this resolution are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such resolution nor revive any resolution thereby.
  - **Section 4.** Certification. The Town Clerk shall certify to the passage of this

resolution and make not less than one copy of the adopted resolution available for inspection by the public during regular business hours.
