TOWN OF MEAD, COLORADO RESOLUTION NO. 9-R-2002

A RESOLUTION OF THE TOWN OF MEAD COLORADO, RENAMING 4th STREET WITHIN THE ORIGINAL TOWN OF MEAD AS MAIN STREET.

WHEREAS, on the original plat of the Town of Mead, the public street called 4th Street extended from Welker Avenue (WCR 34) to one block north of Palmer Avenue; and

WHEREAS, 4th Street has served throughout the history of the Town of Mead as the "Main Street" for commercial and societal purposes for the Town; and

WHEREAS, the Town of Mead has as a goal the revitalization of the core area of the original Town of Mead to include the restoration of store fronts, the attraction of commercial businesses into the "downtown" and the revitalization of existing businesses along "Main Street;" and

WHEREAS, in furtherance of these goals, the Board of Trustees of the Town of Mead has determined that it is appropriate to rename the platted street known as 4th Street, extending northward from its intersection with Welker Avenue to its terminus approximately one block north of Palmer Avenue, as "Main Street" and to address those lots fronting on "Main Street" with an appropriate "Main Street" address for all purposes and to notify the U.S. Postal Service, the Weld County Assessors office, the Weld County E-911 Authority and all property owners abutting "Main Street" of the resultant address change:

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEAD, WELD COUNTY, COLORADO; THAT;

- **Section 1.** The platted street now known as 4th Street, in the Town of Mead, Colorado is hereby designated and renamed "Main Street" with appropriate addresses thereon to be assigned by the Town, with said addresses to be communicated to the U.S. Postal Service, the Weld County Assessor's office, the Weld County E-911 Authority and the owners of property abutting thereon and hereafter said addresses shall appear as such in all records of the Town of Mead.
- Section 2. Effective Date. This resolution shall be become effective immediately upon adoption.
- **Section 3.** Repealer. All resolutions, or parts thereof, in conflict with this resolution are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such resolution nor revive any resolution thereby.
- **Section 4. Certification.** The Town Clerk shall certify to the passage of this resolution and make not less than one copy of the adopted resolution available for inspection by

the public during regular business hours.
