TOWN OF MEAD, COLORADO RESOLUTION NO. 2-2000

A RESOLUTION OF THE TOWN OF MEAD COLORADO, NAMING THE COMMON ACCESS EASEMENT SERVING OUTLOT A GRANDVIEW ESTATES FILING NO. 1, AND OUTLOTS B AND C OF GRANDVIEW ESTATES IN THE TOWN OF MEAD AS LAKE LANE FOR ADDRESSING PURPOSES.

WHEREAS, Outlot A Grandview Estates Filing No. 1, and Outlots B and C of Grandview Estates presently are addressed on Weld County Road 13, and although within the Town of Mead have been assigned by the U.S. Postal Services to the Platteville Post Office for mail delivery purposes; and

WHEREAS, it is the desire of the residents of Outlot A Grandview Estates Filing No. 1, and Outlots B and C of Grandview Estates to be addressed and receive mail delivery service from the Mead Post Office as does the remainder of the Grandview Estates; and

WHEREAS, in furtherance of that goal, the residents of Outlot A Grandview Estates Filing No. 1, and Outlots B and C of Grandview Estates have petitioned the Board of Trustees of the Town of Mead to designate and name the platted common access easement as Lake Lane and to address said Outlots with appropriate Dobbins Lane address for all purposes and to notify the U.S. Postal Service and the Weld County Assessors office of the resultant address change:

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEAD, WELD COUNTY, COLORADO; THAT;

- Section 1. The platted common access easement serving Outlot A Grandview Estates Filing No. 1, and Outlots B and C of Grandview Estates is hereby designated and named "Lake Lane" with appropriate addresses thereon to be assigned to Outlots A, B and C by the Town Clerk, with said addresses to be communicated to the U.S. Postal Service and to the Weld County Assessor's office and hereafter appearing as such in all records of the Town of Mead.
- Section 2. Lake Lane Not Accepted for Town Maintenance. It is recognized and agreed by the owners of Outlot A Grandview Estates Filing No. 1, and Outlots B and C of Grandview Estates that Lake Lane is not constructed or maintained to Town of Mead Standards for a public streets and the designation and naming of said common access easement as Lake Lane shall in no event require the Town of Mead to maintain said Lake Lane as a Town of Mead public street.
- Section 3. Effective Date. This resolution shall be become effective immediately upon adoption.
- Section 4. Repealer. All resolutions, or parts thereof, in conflict with this resolution are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such resolution nor revive any resolution thereby.
 - Section 5. Certification. The Town Clerk shall certify to the passage of this resolution
