

RESOLUTION NO. 17-R-2000

A RESOLUTION SUMMARIZING EXPENDITURES AND REVENUES FOR EACH FUND AND ADOPTING A BUDGET FOR THE TOWN OF MEAD, COLORADO FOR THE FISCAL YEAR BEGINNING THE 1ST DAY OF JANUARY, 2001, AND ENDING ON THE LAST DAY OF DECEMBER, 2001.

WHEREAS, the Town Treasurer has been designated to prepare the annual budget for Mead, Colorado, for the fiscal year beginning January 1, 2001, and ending December 31, 2001, and has prepared said budget and submitted it to the Board of Trustees; and

WHEREAS, the Board of Trustees has considered all relevant factors concerning the budget and made all adjustments to the budget deemed appropriate and proper; and

WHEREAS, the Board of Trustees is required by state law to adopt an annual budget prior to December 15, 2000.

NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF TRUSTEES FOR THE TOWN OF MEAD, COLORADO:

Section 1. That the estimated revenue for the various funds of the Town of Mead is:



In the opinion of the Board of Trustees of the Town of Mead, Weld County, Colorado, this Resolution is necessary for the immediate protection and preservation of the public health, safety, convenience, and general welfare, and it is enacted for that purpose and shall be in full force and effect after passage.


