A RESOLUTION AMENDING RESOLUTION NO. 17-R-2000, SUMMARIZING EXPENDITURES AND REVENUES FOR EACH FUND AND ADOPTING A BUDGET FOR THE TOWN OF MEAD, COLORADO FOR THE FISCAL YEAR BEGINNING THE 1ST DAY OF JANUARY, 2001, AND ENDING ON THE LAST DAY OF DECEMBER, 2001.
