

**TOWN OF MEAD, COLORADO  
ORDINANCE NO. 822**

**AN ORDINANCE OF THE TOWN OF MEAD, COLORADO, AMENDING  
SECTION 10-13-70 EXCEPTIONS, TO THE NOISE REGULATIONS.**

**WHEREAS**, it is the intent of the Board of Trustees to modify the noise regulations applicable within the Town of Mead to provide the same exceptions as contained in the state statutes for political subdivisions or other entities not organized for profit, for the purpose of promoting, producing or holding cultural, entertainment, athletic, or patriotic events; and

**WHEREAS**, this exception shall not be construed to preempt or limit the authority of the town to regulate noise abatement;

**NOW THEREFORE, BE IT ORDAINED** by the Board of Trustees of the Town of Mead, Weld County, Colorado, that:

**Section 1.** Section 10-13-70 of the *Mead Municipal Code* is hereby amended by the addition of a new paragraph (c) to read as follows:

“(c) This article is not applicable to the use of property by the state, any political subdivision of this state, or any other entity not organized for profit, including, but not limited to, nonprofit corporations, or any of their lessees, licensees, or permittees, for the purpose of promoting, producing, or holding cultural, entertainment, athletic, or patriotic events, including, but not limited to, concerts, music festivals, and fireworks displays. This subsection (c) shall not be construed to preempt or limit the authority of any political subdivision having jurisdiction to regulate noise abatement.”

**Section 2. Effective Date.** This ordinance shall be published and become effective as provided by law.

**Section 3. Severability.** If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of the Ordinance. The Board of Trustees hereby declares that it would have passed the ordinance including each part, section, subsection, sentence, clause or phrase thereof, irrespective of the fact that one or more part, section, subsection, sentence, clause or phrase is declared invalid.


**Section 4. Repealer.** All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.


**Section 5. Certification.** The Town Clerk shall certify to the passage of this ordinance and make not less than one copy of the adopted Code available for inspection by the public during regular business hours.
