**A RESOLUTION OF THE TOWN OF MEAD, COLORADO, ADOPTING  
THE WELD COUNTY 2021 MULTI-JURISDICTIONAL HAZARD  
MITIGATION PLAN AND AUTHORIZING THE TOWN TO TAKE THOSE  
STEPS NECESSARY TO MAINTAIN AND IMPLEMENT THE  
MITIGATION ACTIONS CONTAINED IN THE PLAN**

**WHEREAS**, the Weld County 2021 Multi-Jurisdictional Hazard Mitigation Plan (the “Plan”) has been prepared in accordance with the FEMA requirements contained in 44 C.F.R. 201.6; and

**WHEREAS**, the Plan has been prepared to meet requirements set forth by FEMA and the Colorado Division of Homeland Security and Emergency Management (DHSEM) for Weld County and its municipalities (including the Town of Mead) to continue to be eligible for funding and technical assistance from state and federal hazard mitigation programs; and

**WHEREAS**, the Town of Mead, in cooperation with the Weld County Office of Emergency Management (Weld OEM), has gathered information to support the preparation of the Plan; and

**WHEREAS**, the Town of Mead, as a local unit of government, has afforded its citizens an opportunity to comment and provide input into the Plan and the mitigation actions contained in the Plan; and

**WHEREAS**, a copy of the Plan is available at the following link: <https://www.weldgov.com/Government/Departments/Office-of-Emergency-Management/Hazard-Mitigation> and a copy is on file with the Town Clerk; and

**WHEREAS**, the Town of Mead Board of Trustees has reviewed the Plan and affirms that it will cooperate with Weld OEM to update the Plan within its five-year expiration date,

**NOW THEREFORE, BE IT RESOLVED** by the Board of Trustees of the Town of Mead, Weld County, Colorado, that:

**Section 1.** The Town of Mead hereby adopts the Plan as the Town’s Multi-Hazard Mitigation Plan and resolves to implement the mitigation actions of the Plan as deemed appropriate.

**Section 2. Effective Date.** This resolution shall become effective immediately upon adoption.

**Section 3. Certification.** The Town Clerk shall certify to the passage of this resolution and make not less than one copy of the adopted resolution available for inspection by the public during regular business hours.
