RESOLUTION NO. 44-R-2021**

**A RESOLUTION OF THE TOWN OF MEAD, COLORADO, APPROVING
AN AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN THE
TOWN OF MEAD AND LOVELAND BARRICADE LLC FOR 2021
PAVEMENT MARKING AND STRIPING APPLICATION SERVICES**

WHEREAS, the Town of Mead is authorized under C.R.S. § 31-15-101 to enter into contracts for any lawful municipal purpose; and

WHEREAS, the Town requires pavement marking services as part of the Town's annual roadway maintenance program (the "Services"); and

WHEREAS, the Town contracted with Loveland Barricade LLC ("Contractor") in 2020 for the Services through a cooperative purchasing arrangement using Contractor's bid prices from City of Loveland Invitation to Bid #2020-33; and

WHEREAS, Town staff recommends renewing Contractor's services for 2021; and

WHEREAS, the Board of Trustees desires to renew Contractor's services by entering into an agreement for professional services with Contractor for 2021; and

WHEREAS, a copy of the agreement for professional services ("Agreement") is attached to this Resolution as **Exhibit 1** and is incorporated herein by reference; and

WHEREAS, the Board of Trustees finds it is in the best interests of the Town to authorize an Agreement with the Contractor in the not-to-exceed amount of **Seventy-Five Thousand Dollars (\$75,000.00)**, based on the unit price(s) set forth in the Agreement and the estimated work quantities associated with the Services for 2021.

NOW THEREFORE, BE IT RESOLVED by the Town of Mead, Weld County, Colorado, that:

Section 1. The Board of Trustees hereby: (a) approves the Agreement with Contractor for the Services in 2021, in substantially the form attached hereto as **Exhibit 1**, for the not-to-exceed amount of Seventy-Five Thousand Dollars (\$75,000.00); (b) authorizes the Town Attorney to make such changes as may be needed to correct any non-material errors or language or to negotiate such changes to the Agreement as may be appropriate and that do not substantially increase the obligations of the Town; and (c) authorizes the Mayor to execute the Agreement on behalf of the Town when in final form.

Section 2. Effective Date. This resolution shall become effective immediately upon adoption.

Section 3. Certification. The Town Clerk shall certify to the passage of this resolution and make not less than one copy of the adopted resolution available for inspection by the public during regular business hours.
