RESOLUTION NO. 46-R-2022**

**A RESOLUTION OF THE TOWN OF MEAD, COLORADO, APPROVING A
MEMORANDUM OF UNDERSTANDING BETWEEN THE ST. VRAIN VALLEY
SCHOOL DISTRICT RE-1J AND THE TOWN OF MEAD RELATED TO CROSSING
GUARDS AND CORNER CAPTAINS**

WHEREAS, the Town of Mead (“Town”) and St. Vrain Valley School District RE-1J (“District”) collaborate to operate and fund two programs that provide crossing guards and corner captains for students to safely cross Town streets (“Programs”); and

WHEREAS, the Town operates and manages the Programs and funds a portion of the crossing guard program; and

WHEREAS, the District funds the corner captain program and a portion of the crossing guard program; and

WHEREAS, the Town and District desire to enter into a Memorandum of Understanding (“MOU”) setting forth their respective obligations related to the Programs in substantially the same form as attached hereto as **Exhibit 1**; and

WHEREAS, the Board of Trustees desires to approve the MOU and delegate authority to the Police Chief to execute the MOU on behalf of the Town when in final form.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of the Town of Mead, Weld County, Colorado, that:

Section 1. The foregoing recitals and findings are incorporated herein as findings and conclusions of the Board of Trustees.

Section 2. The Board of Trustees hereby: (a) approves the MOU in the form attached hereto as **Exhibit 1**; (b) authorizes the Town Attorney in cooperation with the Town Manager and Police Chief to make non-material changes to the MOU that do not materially increase the Town’s obligations; and (c) authorizes the Police Chief to execute the MOU on behalf of the Town when in final form.

Section 3. Effective Date. This resolution shall be effective immediately upon adoption.

Section 4. Repealer. All resolutions, or parts thereof, in conflict with this resolution are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such resolution nor revive any resolution thereby.

Section 5. Certification. The Town Clerk shall certify to the passage of this resolution and make not less than one copy of the adopted resolution available for inspection by the public during regular business hours.
