TOWN OF MEAD, COLORADO RESOLUTION NO. 56-R-2022

A RESOLUTION AUTHORIZING THE MAYOR AND TOWN MANAGER TO EXECUTE DOCUMENTS CONCERNING A WATER TAP EXCHANGE WITH LITTLE THOMPSON WATER DISTRICT AND RATIFYING THE EXECUTION OF A STATEMENT OF AUTHORITY

WHEREAS, the Town of Mead ("Town") has constructed a new public works facility, which has need of water service through the Little Thompson Water District ("LTWD"); and

WHEREAS, Town staff arranged with LTWD to exchange an old tap for a new tap at the new public works facility to save a significant expense related to water tap fees for the facility; and

WHEREAS, the proposed tap exchange involves abandoning an underutilized 5/8 inch tap located at 501 3rd Street for a new 5/8 inch tap at the new public works facility; and

WHEREAS, LTWD considers the tap exchange a real estate transaction and therefore requires the completion and execution of a statement of authority designating the persons who are authorized to sign real estate transaction documents on behalf of the Town related to this tap exchange; and

WHEREAS, the Board wishes to delegate authority to the Town Manager and the Mayor to execute such documents as are necessary to accomplish the water tap exchange with LTWD and ratify the execution of the statement of authority attached to this Resolution.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of the Town of Mead, Weld County, Colorado, that:

- **Section 1.** The foregoing recitals and findings are incorporated herein as findings and conclusions of the Board of Trustees.
- Section 2. The Board of Trustees hereby: (a) authorizes the Town Manager and the Mayor to each have authority to sign such documents as may be necessary to effect the water tap exchange with LTWD and the water tap hook up and commencement of water service for the Town's new public works facility; and (b) ratifies the signing of the statement of authority attached hereto as Exhibit 1.
 - **Section 3. Effective Date.** This resolution shall be effective immediately upon adoption.
- **Section 4.** Repealer. All resolutions, or parts thereof, in conflict with this resolution are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such resolution nor revive any resolution thereby.
- **Section 5.** Certification. The Town Clerk shall certify to the passage of this resolution and make not less than one copy of the adopted resolution available for inspection by the public during regular business hours.
