RESOLUTION NO. 61-R-2022**

**A RESOLUTION OF THE TOWN OF MEAD, COLORADO, APPROVING A
PURCHASE ORDER FOR A NEW HOLLAND WM120 TRACTOR AND
MOWER IN THE AMOUNT OF NINETY-TWO THOUSAND TWO
HUNDRED DOLLARS (\$92,200.00)**

WHEREAS, the Town of Mead desires to purchase a tractor and mower that will be used in various Public Works-related activities in the Town; and

WHEREAS, the Town of Mead appropriated one hundred thousand dollars and no cents (\$100,000.00) for the purchase of a tractor and mower in the approved 2022 Town budget; and

WHEREAS, the Public Works Department is recommending that the equipment be acquired from Modern Farm Equipment, a Nebraska corporation (d/b/a High Plains New Holland) (the "Supplier") for a purchase price of **NINETY-TWO THOUSAND TWO HUNDRED DOLLARS (\$92,200.00)**; and

WHEREAS, the Public Works Department secured a total of three (3) quotes for the equipment and is recommended acquisition of the equipment from the Supplier based on lead time and pricing; and

WHEREAS, the Board of Trustees desires to approve a Purchase Order with the Supplier to acquire the equipment, in substantially the form attached hereto as **Exhibit 1**.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of the Town of Mead, Weld County, Colorado, that:


Section 1. The Board of Trustees hereby: (a) approves the issuance of a Purchase Order for the tractor and mower in substantially the form attached hereto as **Exhibit 1**; (b) authorizes the Town Manager, or her designee, to execute the Purchase Order on behalf of the Town and to deliver the Purchase Order same to the Supplier once in final form; and (c) authorizes the Town Manager, or her designee, to take such other actions as necessary to ensure that the equipment is timely delivered to the Town.


Section 2. Effective Date. This resolution shall become effective immediately upon adoption.

Section 3. Certification. The Town Clerk shall certify to the passage of this resolution and make not less than one copy of the adopted resolution available for inspection by the public during regular business hours.
