

**TOWN OF MEAD, COLORADO
RESOLUTION NO. 65-R-2022**

**A RESOLUTION OF THE TOWN OF MEAD, COLORADO, APPROVING AN
INTERGOVERNMENTAL AGREEMENT BETWEEN THE TOWN OF MEAD AND THE
CITY OF LONGMONT FOR MEMBERSHIP ON LONGMONT'S SPECIAL WEAPONS
AND TACTICS TEAM**

WHEREAS, the Town of Mead ("Town") and the City of Longmont ("Longmont"), as Colorado governmental entities, are empowered pursuant to Article XIV, §18 of the Colorado Constitution and C.R.S. §§ 29-1-201, *et seq.*, to cooperate or contract via intergovernmental agreement to provide functions, services, or facilities authorized to each cooperating government; and

WHEREAS, the Town entered into an intergovernmental agreement with Longmont for calendar year 2021 that allowed members of the Mead Police Department to be assigned to the City of Longmont Special Weapons and Tactics ("SWAT") Team and allowed the Town and Longmont to provide a cooperative response to critical incidents in their respective communities and additional and specialized training and resources for the Mead Police Department and the residents of the Town; and

WHEREAS, the Town desires to enter into a new intergovernmental agreement with Longmont for the same purposes for 2022; and

WHEREAS, the Town Board of Trustees finds it is in the best interest of the public health, safety and welfare to approve the Intergovernmental Agreement Between the City of Longmont and the Town of Mead for Membership on the City of Longmont Special Weapons and Tactics Team, in substantially the form attached to this Resolution as **Exhibit 1** (the "Agreement") and delegate authority to the Mayor, Mayor Pro Tem, or Town Manager to execute the Agreement on behalf of the Town; and

WHEREAS, the Board of Trustees also specifically desires to delegate authority to the Mayor, Mayor Pro Tem, or the Town Manager to execute future amendments or extensions to the Agreement, or to execute a similar agreement with the City of Longmont in future years, provided that: (1) the Town has appropriated funds for the amendment, extension, or new agreement, and (2) the Town Attorney has approved the amendment, extension, or new agreement as to form.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of the Town of Mead, Weld County, Colorado, that:

Section 1. The foregoing recitals and findings are incorporated herein as findings and conclusions of the Board of Trustees.

Section 2. The Board of Trustees hereby: (a) approves the Agreement in substantially the form attached hereto; (b) authorizes the Town Attorney, in cooperation with the Chief of Police, to negotiate revisions to the Agreement that benefit and protect the Town and do not increase the Town's financial obligations; (c) authorizes the Mayor, Mayor Pro Tem, or Town Manager to execute the Agreement on behalf of the Town when in final form; and (d) authorizes the Mayor, Mayor Pro Tem, or the Town Manager to execute future intergovernmental agreements with the City of Longmont for Mead's participation on the SWAT Team so long as the Town's financial obligations in the applicable amendment, extension, or new agreement have been budgeted and appropriated in the applicable budget year and on the condition that the applicable amendment, extension, or new agreement has been reviewed and approved as to form by the Town Attorney.

Section 3. Effective Date. This resolution shall be effective immediately upon adoption.

Section 4. Repealer. All resolutions, or parts thereof, in conflict with this resolution are hereby repealed, provided that such repealer shall not repeal the repealer clauses of such resolution nor revive any resolution thereby.

Section 5. Certification. The Town Clerk shall certify to the passage of this resolution and make not less than one copy of the adopted resolution available for inspection by the public during regular business hours.
