Town of Mead Ballot Issue 2D

SHALL THE TOWN OF MEAD TAXES BE INCREASED NOT MORE THAN \$2,900,000 ANNUALLY BEGINNING JANUARY 1, 2022 AND BY SUCH AMOUNTS AS ARE RAISED ANNUALLY THEREAFTER BY AN ADDITIONAL SALES AND USE TAX IMPOSED AT A RATE OF ONE PERCENT (1.0%), BEGINNING JANUARY 1, 2022 TO PAY EXCLUSIVELY FOR STREET IMPROVEMENTS IN THE TOWN OF MEAD, AND SHALL THE TAX REVENUES COLLECTED:

- BE RETAINED IN A SEGREGATED ACCOUNT SEPARATE FROM ALL OTHER TOWN FINANCIAL ACCOUNTS, AND
- BE USED ONLY TO PAY FOR STREET IMPROVEMENTS IN THE TOWN OF MEAD AND NEVER BE TRANSFERRED INTO THE TOWN GENERAL FUND OR USED FOR ANY PURPOSE OTHER THAN STREET IMPROVEMENTS.

AND SHALL THE RESULTING REVENUE AND INVESTMENT EARNINGS THEREON BE
